Fibergate to Launch Satellite Communication Service

Name	Fibergate Inc. (Securities Code: 9450)
Overview	Fibergate and its wholly owned subsidiary BizGenesis will launch provision of a satellite communication service as a measure for clients to achieve their business continuity plans. The service is assumed to be provided to various companies, buildings of local governments, regional evacuation areas, hospitals and senior care facilities, apartments, etc., and by combining it with the free Wi-Fi service Fibergate and BizGenesis provide, it can be used normally as a free Wi-Fi spot using optical lines. In the event a disaster occurs and internet access through cellphones and optical lines becomes unavailable, it will automatically switch to satellite communication enabling continued use of the Wi-Fi service.
BCP measures	As for business continuity plan measures of IT systems, the typical measures are conducting duplication of data centers and use of cloud with disaster recovery in mind, but both of these measures require internet communication. Recent extreme weather events and natural disasters have grown in intensity compared with events of several decades ago, and that trend is expected to continue. Therefore, enhancing the resilience of internet communication is necessary, and we hope to contribute to this. In addition, by establishing an environment that enables safety confirmation in the event of an emergency, we also aim to contribute to the peace of mind in daily lives.
Service features	 1. Automatic restoration through automatic switching In the event communication through the optical line becomes unavailable, the service will automatically switch to satellite communication, and when communication through the optical line is restored, the service will automatically switch back. 2. Remotely monitoring whether the line is working normally or not Satellite communication will be remotely monitored to verify whether it can be used at any time or not, and a report will be regularly outputted and delivered to the location owner. 3. Free of charge for regular use
	The usage fee for satellite communication will only be incurred when it is used in a time of disaster. 4. Compensation for antenna There will be plans to provide compensation for failure, damage and such of the satellite antenna when the cause is lightning, hailstorm, etc.
